(PRT Club Members receive a 50% discount to rental rates. Discount does not apply to fees.)



## NOTES:

- Rates and additional fees noted below are good from 01.01.2023 – 12.31.2023.
- All event rates include set-up and take-down of tables and chairs plus a four (4) hour maximum decorating window.
- The deposit is refundable within fourteen (14) days after the event per the contract clause(s).
- If the event is cancelled sixty (60) days before the event, the deposit will be returned.
- Security is required for all events except for three (3) hour events between 10:00 am – 4:00pm, Monday–Thursday.

<b>Security</b> (Provided by PRTWC)	NO alcohol at event	\$200 (fee includes a minimum of one (1) security person)
	Alcohol at event <b>OR</b> Over 100 guests	\$400 (fee includes a minimum of two (2) security persons)
<b>Pre-Event Activities</b>	<ul style="list-style-type: none"> <li>▪ \$100 per hour for <u>any</u> amount of time over a total of four (4) hours.</li> <li>▪ \$25 per hour if ANY lights or the air conditioning are left on after the facility is vacated.</li> </ul>	
<b>Set Up</b>	<ul style="list-style-type: none"> <li>▪ An additional fee of \$100 will be charged for table/chair/umbrella set up on the Patio.</li> <li>▪ If any changes to room or patio setup are requested after it has been completed per the original agreement, a <u>minimum</u> \$25 per hour fee will be assessed for the changes.</li> </ul>	
<b>Overtime</b>	If any event type noted above goes over the hours agreed to in the <i>Contract</i> , an Overtime Fee of \$300 per extra hour or portion thereof will be assessed.	
<b>Additional</b>	Additional charges may apply: <ul style="list-style-type: none"> <li>▪ Depending upon the event and, if applicable, will be noted in the <i>Contract</i>.</li> <li>▪ Be assessed <u>after</u> the event as noted above or if extensive damage occurs or additional cleanup is required. Additional charges will be deducted from the deposit.</li> </ul>
